On December 20, 2019, tax reform legislation commonly known as the Taxpayer Certainly and Disaster Tax Relief Act was passed, resulting in modifications to existing tax law, particularly repealing the Federal taxation of transportation fringe benefits on exempt employers. While there were no material effects on the consolidated financial statements as a result of the Act, management is still evaluating the ongoing impact of the Act on the Association and the Foundation.
