Costs include the hotel meeting space, printed materials, catering supplies and contracted services provided at the conference site to implement activity. There were 449 attendees participating in the 2020 conference. The conference is 2 1/2 days in length.

Workshops and Seminars: In this fiscal year NWHHA provided a Small Hydro Workshop, Technical Workshop and Fall Regional Workshop in Bend, OR and Wenatchee, WA; tours were included at each event. Approximately 150 attended the small hydro and technical workshops and approximately 120 attended the fall regional workshop. The workshops provided education to a variety of industry members (consultants, generators, suppliers, etc.). Revenue and expenses for all workshops and seminars are listed above.
