Due to the impacts of the COVID-19 pandemic, the organization was contemplating various cost reduction strategies, including the elimination of their annual financial statement audit. Instead of an audit, they had decided to engage their independent audit firm to conduct a review of the financial statements. However, it was later determined that the organization must issue audited financial statements under its bylaws. Due to this change in course, the audit process was delayed, which has also resulted in a delay in the issuance of the financial statements. The organization's independent audit firm will issue audited financial statements, but the organization will not obtain them until after the filing of the tax return. The consolidated audited financial statements for the years ending 3/31/21 and 3/31/20 are scheduled for release by June 2021. The CTCPAS Board will fully review the Form 990 tax return and audited financial statements upon delivery of the final consolidated audited financial statements of the CTCPAS for the years ending 3/31/21 and 3/31/20, currently scheduled for June 2021. Should new information be forthcoming upon release of the audited financial statements that would require changes in the previously filed Form 990 tax return for 3/31/20 (i.e., this tax return), an amended Form 990 tax return will be filed accordingly.
