In addition, the Committee reviews benchmarking data, including comparable survey data from the Council of Engineering and Scientific Society Executives (CESSE), the Georgia Society of Association Executives (GSAE), the American Society of Association Executives (ASAE), and other relevant data, including a survey conducted by the American Research Company on non-profit executive compensation, which IISE participated in. Relevant comparisons are drawn in the following categories: overall, southern region, 501(c)(3), budget size, staff size and tenure in the position. This data is provided to the Personnel Committee between December and February. The Committee members meet with the ED in February to discuss the matter. These discussions often carry into the March Board meeting. The members of the Committee also meet privately, without the ED. Based on the evaluation, ratings, survey data and discussions, the Committee reaches a decision regarding compensation. Then, a letter is sent to the ED that is signed by all members of the Committee which states the decision. The letter is copied to Donna Calvert to ensure transparency.
