THE MAINE MASONIC CHARITABLE FOUNDATION OF THE GRAND LODGE OF MAINE CONDUCTS CHARITABLE ACTIVITIES ACROSS THE STATE. MUCH OF THIS ACTIVITY IS IN CONJUNCTION WITH 180 MASONIC LODGES AND 24 DISTRICT ASSOCIATIONS OF LODGES. THE FOUNDATION ACTIVELY ENCOURAGES CONTRIBUTIONS FROM THE LODGES, THEIR MEMBERS, AND THE PUBLIC. BEQUESTS AND LEGACY GIFTS ARE ALSO ENCOURAGED. ALTHOUGH THE FOUNDATION IS NOT A MEMBERSHIP ORGANIZATION, THE LODGES ARE. DUES ARE REASONABLE AND MEMBERSHIP IS AVAILABLE TO ALL ECONOMIC GROUPS WITHIN MAINE. THERE ARE APPROXIMATELY 15,000 MEMBERS OF THE MASONIC FRATERNITY IN THE STATE, AS WELL AS NON-MASONIC MEMBERS OF THE PUBLIC, WORKING WITH THE CHARITABLE FOUNDATION TO BENEFIT THEIR COMMUNITIES IN VARIOUS WAYS. THE ORGANIZATION SPONSORS SEVERAL PROGRAMS INTENDED TO BENEFIT THE COMMUNITY AS A WHOLE. THE FOUNDATION PROVIDES FUNDING, AND MASONS PROVIDE VOLUNTEER TIME. NON-MASONS ACTIVELY WORK ALONGSIDE THE MASONS IN IMPLEMENTING THESE PROGRAMS. THERE ARE TIME TESTED PROGRAMS THAT THE FOUNDATION SUPPORTS AND NEW, INNOVATIVE PROGRAMS THAT THE FOUNDATION HAS STARTED IN RECENT YEARS TO BETTER SERVE THE STATE OF MAINE. OUR BIKES FOR BOOKS PROGRAM CONTINUES TO EXPAND BY LEAPS AND BOUNDS ACROSS THE STATE. THE PROGRAM IS INTENDED TO BE EXECUTED IN CONCERT WITH A SCHOOL'S READING INITIATIVE TO SUPPORT LOCAL SCHOOLS. EACH YEAR, WE HAVE SEEN AN INCREASE IN THE NUMBER OF LODGES WHO ARE GOING INTO THE COMMUNITY, REACHING SCHOOLS TO PROPOSE A PARTNERSHIP, ENGAGE THE COMMUNITY TO RAISE FUNDS, AND SEE FREE BIKES AND HELMETS INTO THE HANDS OF WORTHY CHILDREN WHO HAVE EARNED A REWARD FOR THEIR EFFORTS. THE FOUNDATION AWARDED OVER \$155,000 UNDER THIS PROGRAM, AN INCREASE OF 9% FROM 2019. OUR OTHER MATCHING GRANT PROGRAMS INCLUDE THE COMMUNITY BETTERMENT GRANT, YOUTH ACTIVITIES GRANT, AND PROJECT GRADUATION GRANT. THE COMMUNITY BETTERMENT GRANT IS TO ASSIST LODGES IN HELPING THEIR LODGES POSITIVELY IMPACT THEIR COMMUNITIES IN A VARIETY OF WAYS. THE FOUNDATION HAS AWARDED OVER \$45,000 IN GRANTS DURING THIS FISCAL YEAR SHOWING A 27% INCREASE IN FY20. THE YOUTH ACTIVITIES GRANT IS AVAILABLE TO ASSIST LODGES IN YOUTH RELATED ACTIVITIES IN THEIR COMMUNITIES. THE PROJECT GRADUATION GRANT ASSISTS LODGES IN SUPPORTING THE SAFETY OF THE TEENS GRADUATING HIGH SCHOOL FROM THEIR COMMUNITIES WITH THE PROJECT GRADUATION EFFORTS IN THEIR TOWNS. THE FOUNDATION HAS AWARDED OVER \$67,000 IN GRANTS DURING THIS FISCAL YEAR SHOWING A 35% INCREASE FROM FY2019. THE FOUNDATION HAS A GENEROUS AND ROBUST RELIEF PROGRAM, WHEREBY A LODGE MAY WORK WITH AN INDIVIDUAL OR FAMILY TO ASSIST FINANCIALLY IN TIMES OF NEED. THE LODGE WILL HELP TO COMPLETE AN APPLICATION WHEREBY THE PARTICULAR DETAILS OF A SITUATION ARE COLLECTED AND EXAMINED. RELIEF MONEY WILL BE PROVIDED FOR A VARIETY OF CAUSES, SUCH AS THE RENOVATION OF A BATHROOM FOR HANDICAPPED ACCESS, ASSISTANCE WITH MEDICAL BILLS AFTER A LONG ILLNESS, PROVIDING HEATING OIL DURING THE WINTER MONTHS, AND MORE. THE INTENT OF THESE RELIEF DOLLARS IS TO PROVIDE SOMEONE WHO HAS FALLEN ON HARD TIMES A BIT OF RESPIRE. RELIEF ACCOUNTED FOR OVER \$101,000 WHICH WAS A 27% INCREASE OVER THE PREVIOUS FISCAL YEAR. THE BROTHERHOOD RELIEF GRANT IS LESS CUMBERSOME TO OBTAIN, BUT ALSO HAS A \$500 MAXIMUM GRANT AMOUNT. THIS RELIEF GRANT IS DESIGNED TO BE A SPEEDY DISTRIBUTION TO OFFSET THE PAINS OF A LARGER PROBLEM. ONE OF THE FIRST BROTHERHOOD RELIEF GRANTS GIVEN OUT WAS TO A FAMILY WHO HAD LOST THEIR HOUSE IN A FIRE. IT ENABLED THEM TO QUICKLY PURCHASE NEW CLOTHES AND FOOD WHILE INSURANCE MATTERS WOULD ADDRESS THE REST OF THEIR NEEDS. THESE RELIEF DOLLARS ARE FOR MASONS AND NON-MASONS ALIKE. BROTHERHOOD RELIEF GRANTS WERE ALMOST \$42,000 IN FY20 AND SHOWED A 18% INCREASE IN THE LAST YEAR. THE FOUNDATION HAS ALSO ASKED THE MEMBERS OF THE GRAND LODGE OF MAINE AND ITS CONSTITUENT LODGES TO SUPPORT VARIOUS RELIEF PROGRAMS IN AND OUT OF THE STATE OF MAINE. ONE OF THE MORE SUCCESSFUL HAS BEEN OUR SUPPORT OF THE WREATHS ACROSS AMERICA PROGRAM. THE TRUSTEES OF THE FOUNDATION FELT THAT OUR GOALS WERE MORE CLOSELY ALIGNED WITH THE DIRECTION THAT NAMI MAINE WAS TAKING TO SERVE TO ADDRESS MENTAL ILLNESS ISSUES WITH TEENS AND ADOLESCENTS IN OUR STATE. THE FOUNDATION HAS FUNDED A PROGRAM WHEREBY SCHOOLS CAN SEEK FINANCIAL ASSISTANCE IN TRAINING THEIR STAFF IN ADDRESSING AND IDENTIFYING CHILDREN WHO COULD BE AT RISK OF SUICIDE IN THEIR SCHOOLS. IT IS CLEAR THAT NAMI MAINE IS THE ABSOLUTE EXPERT IN THIS AREA, AND THEIR REACH ACROSS THE ENTIRE STATE MADE THIS AN EASY CHOICE FOR FUNDING.
