In the case of the classroom grants, the 10 \$300 grants are awarded to qualified schools who also agree to provide a final grant report. Reasearch grants are competative and the award is \$5,000. Eligible applicants may be students, professionals, or individuals. However, the vast majority of recipients are afiliated with an academic or research organization.
