Provide information, create public awareness, initiate programs for their health and safety. Organize volunteers to assist them in their homes, rides to doctors and arrangements for grocery shopping.

Remnant part of a \$200,000 Federal HUD/CDBG funding through the City of Thousand Oaks, CA whereby SAFE is a contracted sub-recipient. The grant extends over multiple accounting periods. \$105,000 fell into SAFE's current fiscal year. All rehabilitations are within senior mobile home parks.

1. Provided three (3) central heating and a/c systems and four (4) central a/c units for seven (7) senior citizens in various mobile parks. Ages: 72, 77, 77, 80, 87, 87 and 92. Five (5) of very low income and two (2) of extremely low income. Total \$62,000.

2. Removed old leaking windows from eight (8) homes in various senior mobile home parks and replaced all windows with double glazed low "E" energy efficient windows with ADA compliant latches. Ages: 65, 68, 69, 71, 79, 84, 84 and 91. Five (5) of very low income and three (3) of extremely low income. Total \$35,850.

3. Provided four (4) leveling of mobile homes, one (1) water heater and one (1) electrical repair in various senior mobile home parks. Ages: 65, 72, 75, 79, 79, and 87. Five (5) of very low income and (1) of extremely low income. Total \$6,950.

Twelve (12) of the (19) seniors in this part of the home rehabilitation project are disabled.
All grant recipients are on title of their homes.

4b (Code:) (Expenses \$ 5,000 including grants of \$ 104,000) (Revenue \$ 0)
Remnant part of a \$145,000 Federal HUD/CDBG funding through the City of Thousand Oaks, CA whereby SAFE is a contracted sub-recipient. The grant extends over multiple accounting periods. \$104,000 fell into SAFE's current fiscal year. All rehabilitations are in mobile homes located in various senior mobile home parks.

1. Provided two (2) central heating and a/c systems, one (1) central a/c system and one (1) central heating system for four (4) seniors. Ages: 78, 87, 91 and 91. Two (2) of very low income and two (2) of extremely low income. Total \$36,050.

2. Provided three (3) new roofs and nine (9) complete home replacements of old leaking windows with new double glazed low "E" energy efficient ADA compliant windows in various senior mobile home parks. Ages: 67, 70, 72, 73, 77, 77, 80, 81, 81, 83, 87 and 89.

Eight (8) of the (16) seniors in this part of the rehabilitation project are disabled.
All recipients are on title of their mobile homes.

SAFE has small amounts donated to provide for less expensive projects needed by its target demographic of very low and extremely low income seniors and Veterans.

Provided (1) water heater for a low income senior, (1) new entrance door for an extremely low income senior, repaired stairs for a low income senior. These are among the small things SAFE provides for our elderly and aged seniors in financial stress.

Rehabilitation is contracted to licensed and approved contractors. Three bids are collected to assure the best value for the grants. SAFE operates on a non-profit basis without payroll or compensation of any kind for its officers and volunteers. SAFE provides services to seniors who live in homes that are unsafe and need repairs for very low and extremely low income seniors which are far beyond their means. These seniors can remain in their homes free from the burden of homelessness and live in a safe and healthful environment.
