We have over 40 Supporting organisations. In 2019-20 Educate Girls was selected as an Audacious Project. A consortium of many donors from USA have supported Educate Girls as an Audacious Project (a 5-year program for the period 2019 - 2024) to help bring 1.5 m girls back to school in India. Educate Girls has a diversified governing body with Michael Pollock as our Board Chairman and Gaurav Gupta, John Somaza, Lisa O'Driscoll, and Safeena Husain as the other members of our Board of Directors. The governing body is chosen specifically because of its special knowledge and expertise in the field of educating girls. Historically, Educate Girls has received grants under USD 3 mn per year from individual philanthropists, retail, foundations, and corporations. However, only after being selected as an Audacious Project in 2019, our funding has gone up significantly. This exceptional grant is for the 5-year program (2019-2024) and is supported by a consortium of funders - most of them are from the USA. Because it is an exceptional grant for Educate Girls, it demonstrates a sudden surge in our income and makes our funding appear less diversified. Our Public Support Score for FY19-20 stands @ 29.8% marginally lower than the threshold of 33.33%. This year and in the years to come, we will continue to raise smaller sized funds from a broader donor pool/general public to maintain our public support status.
