One kitty was returned to her owner. One remains in foster and sadly, we lost 14 to illness. Nine of our kitties required serious medical care (>\$,1000), and another eight required care with costs between \$500-\$1,000. Our adoption fees are generally \$150. Approximately 79 of our kitties had medical costs less than the adoption fee (and some only just).
