Prior to the Merger, the Foundation was the primary owner of Tyndale House Publishers, Inc., a C-corporation whose mission was to publish and sell Bibles and Christian literature throughout the world. The merger was formed in order to ensure that the combined entity has the best opportunity to fulfill its calling and purpose in the future. Subsequent to the merger, all of the outstanding shares of Tyndale House Publishers, Inc. were dissolved and substantially all remaining assets of Tyndale House Foundation were donated to Tyndale House Ministries. The transaction was treated as an accounting merger with assets carried over at their historical cost.</p> |
