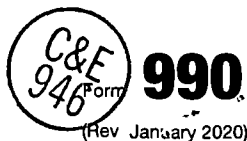

Many community support activities are in the services provided by the Elks. Major assistance is available to needy families in the community. At Christmas time, food baskets are distributed, along with gifts for children. There is a Community Assistance Program that offers help to Springfield Residents only. Included in this program is assistance to schools and school sports teams. There is a local scholarship program and Student of the Month program. A Snack Pack program which has been instituted to furnish non-perishable snacks for the weekend to children who attend a local elementary school. The Lodge, also participates in many Veteran related programs, including the annual "Stand Down" event for all Veterans, but with special assistance provided to homeless Veterans. The Lodge, also assisted the local Fire Department in establishing a program to provide smoke detectors to members of the local community who did not have a working smoke detector in their home.

Lodge supported member activities include a dining establishment, BINGO, music, access to State Lottery and various other entertainments. In addition, needed assistance is provided to any member of the Elks and their family.

Each month, member, volunteers publish and distribute a Fraternal bulletin. Approximately 600 copies are distributed monthly.
