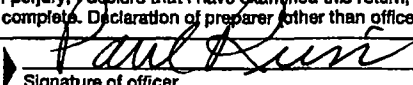

THIS LOWER LEVEL OF DONATIONS COMBINED WITH THE ONE YEAR LARGE INCREASE IN INVESTMENT INCOME IN THE PRIOR YEAR LED TO THE ORGANIZATION'S PUBLIC SUPPORT PERCENTAGE AGAIN FALLING BELOW 66 2/3%.

THE ORGANIZATION BELIEVES THIS IS A TEMPORARY SITUATION THAT WILL TURN AROUND IN SUBSEQUENT YEARS.
