PART I, LINE 2:	In August 2019 all British universities and university colleges were notified of the forthcoming Kennedy Scholarship competition and advertisements were placed on a range of websites. The Trustees have provided, through the Trust's office, an advisory service to those enquiring about study at Harvard and MIT. Applications were submitted online, through the Trust's website, and 160 applications were received. In January 2020, 26 outstanding candidates were called to interview and ten students were provisionally selected to receive scholarships. Ten awards were confirmed by August 2020, following the students' admission to Harvard or MIT. Due to unprecedented disruptions stemming from the Coronavirus pandemic, however, the Trustees agreed to defer scholarships for those awardees who sought and received deferred offers of admission. Ultimately, the Trust provided financial support for two new Kennedy Scholars who began their courses in the 2020-21 academic year, while all other new awards were deferred. In addition, our Scholar from 2019-20 received tuition and health fees for a second year, enabling them to continue their Harvard degree. Kennedy Summer Research Scholarships enable British citizens enrolled on doctoral programmes at Harvard and MIT to complete a particular research project over the summer. Harvard International Office and MITs Manager of Graduate Fellowships advertised the opportunity on behalf of the Trust in the late autumn of 2019. Four applications were received by early January 2020 and the trustees made a single award. The Trustees stayed in contact with former Kennedy Scholars through their support of the Kennedy Scholars' Association. A directory of former Scholars was produces and circulated to all former Scholars and to Trustees in October 2018.
