Programs often include post-film speakers and discussions. Our primary event is the film festival held in March. This festival lasts approximately 8 days, with programs in Portland, Brunswick, Lewiston, Waterville, Bangor and Rockland. Approximately 3,000 film goers attend. In addition to the film festival in March, the organization also organizes various film events in the fall and spring and works with schools to present festival films in educational environments.
