SUCH REQUESTS ARE PRESENTED TO THE GOVERNING BOARD AND ARE DECIDED BY THE BOARD ON A CASE-BY-CASE BASIS AFTER CONSIDERING THE FACTS, CIRCUMSTANCES AND RELEVANCE OF THE REQUEST.
