THE COLLEGE PURSUED ITS MISSION WITH INTEGRITY WITH A NUMBER OF TEMPORARY MODIFICATIONS TO ITS PROGRAMS. THE COLLEGE RESPONDED TO GOVERNMENT SHUTDOWN ORDERS BY SHIFTING FROM IN-PERSON INSTRUCTION TO REMOTE INSTRUCTION IN OUR TRADITIONAL UNDERGRADUATE PROGRAM AND CLASSROOM GRADUATE PROGRAMS. INSTRUCTION WAS CONDUCTED USING A VARIETY OF ONLINE INSTRUCTIONAL METHODS, OFTEN USING VIDEO INSTRUCTION TECHNOLOGY. THE COLLEGE SHIFTED ITS STUDENT SUPPORT ACTIVITIES TO AN ONLINE MODALITY FOR A NUMBER OF SERVICES INCLUDING STUDENT SUPPORT SERVICES (TUTORING), HEALTH SERVICES, STUDENT LIFE/DEVELOPMENT, AND MENTAL HEALTH COUNSELING. RESIDENT STUDENTS RECEIVED REIMBURSEMENT FOR ROOM AND BOARD AND FEES FOR A PROPORTION OF THE SEMESTER WHERE REMOTE INSTRUCTION WAS REQUIRED. THE COLLEGE REFUNDED \$1,423,757 TO RESIDENT STUDENTS IN 2020. EMPLOYEES WHO WERE ABLE TO WORK FROM HOME, DID SO WITH TECHNOLOGY SUPPORT. FULL-TIME AND REGULAR PART-TIME EMPLOYEES THAT COULD NOT WORK FROM HOME WERE PAID THEIR NORMAL WAGES DURING THE MANDATORY SHUTDOWNS. GENERALLY, THE COLLEGE MAINTAINED EMPLOYMENT OF FACULTY AND STAFF THROUGH SHUTDOWN PERIOD. THE COLLEGE APPLIED FOR AND WAS GRANTED A SMALL BUSINESS ASSOCIATION LOAN UNDER THE PAYCHECK PROTECTION PROGRAM (SBA PPP) FOR \$3.1M. THE COLLEGE RECEIVED BOTH INSTITUTIONAL GRANTS AND STUDENT FINANCIAL ASSISTANCE GRANTS THROUGH THE CARES ACT. PLANNING EFFORTS FOR THE FALL 2020 COMMENCED WITH A FOCUS FOR FLEXIBILITY AND PRIORITY OF RESUMING IN-PERSON INSTRUCTION IN THE FALL OF 2020. ON MARCH 27, 2020, PRESIDENT TRUMP SIGNED INTO LAW THE CORONAVIRUS AID, RELIEF, AND ECONOMIC SECURITY ACT (CARES ACT).
