THE COST OF THAT PROJECT WAS ABSORBED FROM EXISTING FUNDS. THE FOUNDATION'S EXECUTIVE COMMITTEE IS ALMOST CONTINUOUSLY EVALUATING NEW PROJECTS IN ACCORDANCE WITH ITS MISSION AND IT IS ANTICIPATED THAT THE FUNDS HELD BY THE TRIANGLE FOUNDATION WILL BE EXPENDED OVER TIME TO ADD NEW PUBLIC-PRIVATE PROJECTS. SOURCES OF SUPPORT. CONSISTENT WITH THE DISCUSSION ABOVE, THE TRIANGLE FOUNDATION'S SOURCES OF SUPPORT HAVE NARROWED OVER THE PAST 7 YEARS. REPRESENTATIVE GOVERNING BODY. THE TRIANGLE FOUNDATION HAS A LARGE BOARD THAT IS BROADLY REPRESENTATIVE OF THE COMMUNITY AND THAT HAS AN INTEREST IN ADVANCING THE MISSION OF THE TRIANGLE FOUNDATION AND ITS PUBLIC-PRIVATE PARTNERSHIP PROJECTS. AVAILABILITY OF PUBLIC FACILITIES OR SERVICES.
