NOTWITHSTANDING, THE BOARD OF DIRECTORS SHALL HAVE THE POWER TO AMEND THE BYLAWS TO MAKE ANY CHANGE: (A) REQUIRED BY THE ASSOCIATION; OR (B) THAT THE BOARD DEEMS NECESSARY OR REQUIRED TO COMPLY WITH AN AMENDMENT TO THE INDIANA NOT FOR PROFIT CORPORATION ACT OF 1971 OR ITS SUCCESSOR NONPROFIT CORPORATION STATUTE. SUCH AMENDMENTS SHALL BE REPORTED TO THE MEMBERSHIP, BUT SHALL NOT REQUIRE MEMBERSHIP APPROVAL.
