Application forms are returned directly to Scholarship Management Services. The deadline for applications is January 31. Scholarship Management Services reviews all applications and prioritizes them based on the information/criteria submitted. SMS submits a list of renewals and a list of the top 10 candidates for new scholarships to the Alliance office by the first of March. The information is sent to the Alliance Scholarship committee for their review and selection of 4 new candidates. Once the total amount of scholarship funds to be disbursed for the upcoming year are determined by the Alliance Finance and Financial Development committee, the Alliance scholarship committee makes their student recommendations to the Alliance Board of Trustees who approves at their April meeting. Once the Board has made their selections, the scholarship management services are notified. Scholarship Management Services notifies all applicants both those who are to receive scholarship awards and those who were not selected. Scholarship recipients are to return the Scholarship Acceptance Form (SAF) to Scholarship Management Services by June 5 and are to notify their school of the award by providing them with a copy of the official letter from SMS. The scholarship recipients are to promptly notify SMS if their school choice, enrollment plans, or permanent home address change after they return the SAF. The award is processed by Scholarship Management Services in one installment. The check is made payable to the scholarship recipients school for their account and mailed to the scholarship recipients permanent home address by August 15. A renewal form is mailed to the scholarship recipients in December. The award is renewable for up to three years or until a bachelors degree is earned, whichever occurs first, provided The Roofing Industry Alliance for Progress continues the scholarship program Renewal is based on maintaining a cumulative 3.0 grade point average on a 4.0 scale in a full-time undergraduate program.
