IN THE EVENT A TRUSTEE IS ELECTED TO THE POSITION OF CHAIR IN THE FINAL YEAR OF HIS OR HER THIRD, THREE-YEAR TERM, SUCH ELECTION WILL SUPERCEDE THE LIMITATION ON SERVICE AND SUBSTITUTE FOR THE ONE-YEAR'S ABSENCE OF MEMBERSHIP. SECTION 2: THE EXECUTIVE COMMITTEE SHALL HAVE THE AUTHORITY TO ACT FOR THE BOARD OF TRUSTEES ON ALL MATTERS EXCEPT PRESIDENTIAL SELECTION AND TERMINATION AND TRUSTEE AND BOARD OFFICER SELECTION, WHICH SHALL BE PRESERVED FOR THE BOARD, CHANGES IN INSTITUTIONAL MISSION AND PURPOSE; CHANGES TO THE CHARTER OR ARTICLE OF INCORPORATION; INCURRING OF CORPORATE INDEBTEDNESS; SALE OF COLLEGE MATERIAL ASSETS OR TANGIBLE PROPERTY; ADOPTION OF THE ANNUAL BUDGET, CONFERRING DEGREES AND AMENDMENT OR CHANGE TO THESE BY-LAWS. THESE BY-LAWS OR OTHER BOARD POLICY MAY RESERVE OTHER POWERS FOR THE BOARD OF TRUSTEES. IN ADDITIONAL TO ITS AUTHORITY TO TAKE ACTION ON EMERGENCY MATTERS THAT CANNOT OR SHOULD NOT BE DEFERRED TO THE NEXT SCHEDULED MEETING OF THE BOARD, THE EXECUTIVE COMMITTEE SHALL OVERSEE THE WORK OF BOARD COMMITTEES, THE COLLEGE'S PLANNING PROCESS ON PLANNING GOALS, AND THE BOARD'S RESPONSIBILITY TO SUPPORT THE PRESIDENT AND EVALUATE HIS OR HER PERFORMANCE, AND IT SHALL REVIEW ANNUALLY THE PRESIDENT'S COMPENSATION AND CONDITIONS OF EMPLOYMENT.
