CPLS provided a before and after school child care program for students enrolled in kindergarten through 6th grade who were in need of a safe and nurturing environment during non-school hours. The program is licensed by both state and county agencies and provided services with a staff dedicated to offering quality care for each child. Expenses \$17,055, including grants of \$0. Revenue of \$18,396. CPLS provided a pre-kindergarten learning center for children ages 3 to 6, with a curriculum designed to prepare young students for the classical education taught in the K-12 program. The program follows the CPLS school calendar with an option for care before and after normal school day hours. The program is licensed by Shawnee County and the State of Kansas. There were 21 children enrolled in this program during the 2019-2020 school year. Expenses \$78,514, including grants of \$0. Revenue of \$79,373.
