THE INVESTMENT COMMITTEE HAD 5 VOTING MEMBERS INCLUDING THE TREASURER, 3 BOARD DIRECTORS, AND 1 OUTSIDE MEMBER WITH RELEVANT EXPERIENCE/EXPERTISE AND 3 NON-VOTING MEMBERS INCLUDING THE PRESIDENT, CEO AND CONTROLLER.
