



The board changed UJFC's fiscal year from a calendar year to a fiscal year that runs from June 1 through May 31; this will coincide more appropriately with our fundraising cycle and program activities going forward.

For the January 1 - May 31, 2020 short fiscal year, UJFC made the following grants:

\$18,000, Jewish Federations of North America ("JFNA")

This organization consolidates gifts from around the country to support Jewish causes in the United States and abroad. Unlike previous years, in which we earmarked our grant to go to specific programs, this year, in light of the COVID-19 pandemic, our gift was unrestricted, allowing the JFNA to apply our funds where they were most needed.

\$25,000, Brody Jewish Center - Hillel at University of Virginia

The Brody Jewish Center is the home of the local chapter of Hillel International, an international organization that serves Jewish college students, primarily those from Reform and Conservative backgrounds, and provides opportunities for religious, educational, cultural and social enrichment. Our funds will be used to help cover the Brody Center's operations during the COVID-19 pandemic, which has forced Brody staff to develop new ways to engage with Jewish University of Virginia students, primarily online. At the same time, donations to the organization have dropped in light of the widespread economic disruption caused by the pandemic.

\$1,000, Rohr Chabad House at University of Virginia

The Rohr Chabad House is the local home of the worldwide Chabad-Lubavitch movement, which promotes Judaism and provides daily Torah lectures and Jewish insights to its members. Chabad House serves Jewish University of Virginia students, primarily those from Orthodox and Conservative backgrounds, as well as members of the larger Charlottesville Jewish community interested in social and educational interaction, particularly Torah study and celebrations of the Jewish holidays. Our funds will support general operations.

This unit of Congregation Beth Israel provides an excellent early childhood program for children from 18 months through kindergarten, Jewish and non-Jewish. It is recognized as among the best preschools in Charlottesville. Because of the school closure required by the Virginia governor's stay-at-home order in light of the COVID-19 pandemic, and the resultant loss of tuition payments, our gift will be used to help pay the preschool teachers until the school can reopen.

\$15,500, Congregation Beth Israel - Senior Connections

This program is run by Congregation Beth Israel to keep senior citizens engaged with the Jewish community in Charlottesville. Latifa Kropf, the program's sole employee, previously ran in-person programs in The Colonnades - Sunrise Senior Living for seniors, including Torah study, Aging Wisely, and holiday celebrations. She also reached out to seniors elsewhere in the area on a one-to-one basis. This year, with seniors in the high-risk category, the stay-at-home order issued by the governor of Virginia in response to the COVID-19 pandemic, meant that all of the Senior Connections work has been virtual. Our funds provide 100% of the support for the program director.

\$2,500, Jewish Oral History Project

Phyllis Leffler, University of Virginia Professor Emerita, runs this program, which is conducting videotaped interviews of Jewish people in Charlottesville, most of whom have been involved in with Congregation Beth Israel in one capacity or another over the years. Professor Leffler, along

with co-authors Jeffrey Hantman and Carol Ely, wrote "To Seek the Peace of the City: Jewish Life in Charlottesville," a history of Charlottesville's Jewish community from the 1880s to the 1960s. Her current work aims to bring the history of Congregation Beth Israel and the Jewish community of Charlottesville into the 21st century. Our funds will be used to transcribe some of the interviews so they can be deposited in the University of Virginia Special Collections Library and maintained there in perpetuity for use by scholars, students and other interested parties.
