IN 2019-2020, THE JUNIOR LEAGUE OF SPARTANBURG PARTNERED WITH THE HUB CITY FARMERS' MARKET TO ESTABLISH A BI-MONTHLY TENT AT WHICH KID-FRIENDLY RECIPES AND SNACKS WERE AVAILABLE. THIS COINCIDES WITH JLS'S KIDS IN THE KITCHEN INITIATIVE. JLS PROVIDES A HEALTHY SNACK AND EXPLAINS THE NUTRITION BEHIND IT AND THAT IT IS IMPORTANT TO PRACTICE HEALTHY EATING HABITS AT HOME. IN ADDITION TO PROVIDING A HEALTHY TREAT, A RECIPE CARD IS PROVIDED SO THE SNACK CAN BE REPLICATED AT HOME. THERE WERE A TOTAL OF 16 MARKETS DURING THIS TIMEFRAME. THE JLS TENT AT THE MARKET SERVED APPROXIMATELY 25 CHILDREN DURING EACH SATURDAY. WE WERE PRESENT TWICE A MONTH AT THE HUB CITY FARMERS' MARKET FOR APPROXIMATELY 8 MONTHS.
