THE COMPENSATION COMMITTEE, A SUB-COMMITTEE OF THE EXECUTIVE COMMITTEE, IS RESPONSIBLE FOR THE ANNUAL EVALUATION AND FOR RECOMMENDATIONS CONCERNING COMPENSATION, PERSONNEL ACTIONS AND OTHER EMPLOYMENT ISSUES RELATED TO THE APPOINTMENT OF THE PRESIDENT. THE COMMITTEE CONDUCTS AN ANNUAL PERFORMANCE APPRAISAL, COLLECTS AND EVALUATES COMPARATIVE SALARY DATA FROM ASSOCIATION OF INDEPENDENT COLLEGES OF ART AND DESIGN (AICAD), 990 DATA, AND PROVIDES A RECOMMENDATION FOR THE PRESIDENT'S ANNUAL COMPENSATION TO THE EXECUTIVE COMMITTEE. THE MEMBERS OF THE EXECUTIVE COMMITTEE OF THE BOARD OF TRUSTEES AND/OR THE FULL BOARD OF TRUSTEES CONDUCT A PERFORMANCE ASSESSMENT. THE EXECUTIVE COMMITTEE REPORTS THE DELIBERATIONS AND RECOMMENDATION TO THE BOARD OF TRUSTEES. THE PRESIDENT EVALUATES AND DETERMINES THE COMPENSATION OF EACH SENIOR OFFICER. THE PRESIDENT REVIEWS THE COMPARATIVE DATA FROM THE ASSOCIATION OF INDEPENDENT COLLEGES OF ART AND DESIGN (AICAD) FOR EACH OF THE SENIOR OFFICERS WITH THE COMPENSATION COMMITTEE. THE VICE PRESIDENT FOR FINANCE AND ADMINISTRATION, THE VICE PRESIDENT FOR ACADEMIC AFFAIRS, THE VICE PRESIDENT FOR HUMAN AND ORGANIZATIONAL DEVELOPMENT, THE VICE PRESIDENT FOR ADVANCEMENT, AND THE VICE PRESIDENT FOR STUDENT LIFE ARE SENIOR OFFICERS. DOCUMENTATION INCLUDES THE DATA USED IN REVIEW AND NOTES TAKEN AT THE COMPENSATION COMMITTEE AND EXECUTIVE COMMITTEE MEETINGS OF PERFORMANCE REVIEW, DATA REVIEW AND DELIBERATIONS.
