To fund this important endeavor, members formed a Luncheon Club - the genesis of today's Tea Room. The Tea Room supports the League's exempt purposes by serving as a training facility where members are educated in the discipline of service, which is then carried into the various community service projects which the League undertakes. The training and education afforded by the Tea Room enables members to be more effective and efficient community volunteers. The Tea Room exclusively serves its Tea Room patron members and their guests.

During 2019-2020 the League served individuals through 35 community projects addressing a broad spectrum of needs in Houston and surrounding areas. League volunteers serve many people - infants, children, women in crisis, families and the elderly; in many places - hospitals, museums, camps and schools; and in many capacities - docents, mentors and program facilitators. During the 2019 - 2020 fiscal year, the League gave approximately \$3.2 million in volunteer time and direct financial support through grants, collaborative efforts and community projects.
