<p>28 Our recognition ceremony where we officially welcomed 8 girls from Eastway Middle School into the program, and formed our Class of 2025. This is a ceremony where we celebrate the initiation of these 7th graders into Circle de Luz. They will be with us for the next 6 years receiving holistic programming, mentoring and a scholarship at the end of their high school graduation. We received a grant from Coca Cola for \$1,000 to cover the ceremony expenses, and received scholarship funding for this class from First National Bank and Bright House Financial. Due to the COVID-19 pandemic our programming had to be moved virtually. Some events (such as our 5K race, State of the Circle, and high ropes), had to be cancelled. As an organization we took precautions to make sure our girls and families had the necessary resources to endure the shutdown.
