We also monitor and track iconic bull elephants, develop infrastructure to establish ongoing ranger presence in vulnerable areas, and provide funding to support local community health, education, and welfare needs.

Anti-poaching work resulted in multiple arrests and convictions, and several live pangolins were recovered and sent for rehabilitation and reintroduction into the wild. Funds were provided for anti-poaching patrol expenses, including wages, rations, fuel, and vehicle repair and maintenance. Funds were provided for research and informer rewards. Funds were provided to purchase two additional vehicles: one for anti-poaching and one for wildlife and habitat research.
