The value of the free medications received by Health West patients was \$3,514,998 Health West also provides medication reconciliation, therapeutic monitoring, wellness promotion, and disease prevention.

Dental Services: Health West provides preventive dental services to prevent diseases of the oral cavity and related structures. Services include cleanings, application of sealants, and diagnostic screening for caries and periodontal disease through the use of dental x-rays. In addition, Health West provides basic general dentistry to diagnose and treat disease, injury, or impairment in teeth including fillings and single unit crowns; non-surgical-endodontic, extractions, and periodontal therapies. For the fiscal year ended May 31, 2020 we served 1,123 patients in 3,618 dental appointments.
