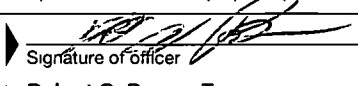

Form 990 EZ - Part III - Line 28 - Arizona Aloha Festivals, Inc had successfully produced the Arizona Aloha Festival for the past 25 years.

Over the years, the Festival has received funding from both state and local arts commissions, local governments, corporations, and the public at large. The Board of Directors provides strong financial oversight and its members come from diverse fields. The chairperson is appointed by the Board and reports directly to them. The Planning Committee is composed of chairs of the committees responsible for operations and programming. All Board of Directors and Planning Committee members are volunteers. The Festival's programming is known throughout the community, state, and region and regularly lands on lists of top events in the Phoenix metro area and Arizona. The strength of the organization lies in its diversity. The Festival enjoys strong support from local South Pacific Islander organizations such as the local Hawaiian Civic Club (30 + years in the Valley), dance schools, performing groups, Hawaiian outrigger canoe clubs and other sports organizations, corporate supporters, and more.

Unfortunately, the 2020 Arizona Aloha Festival was heavily impacted by the Covid-19 pandemic. The Festival was scheduled for March 14-15. We had just about completed setup on the afternoon of March 12 and were preparing for vendors to move in starting early on March 13, when we received a call from the City of Tempe. They told us that due to the now declared pandemic, our permit to hold the event had been cancelled. We immediately took the necessary steps to cancel the event and salvage whatever we could. Unfortunately, since we had completed setup, we had to pay the equipment company and the sound company, causing massive losses to our non-profit organization. Luckily, the organization had saved reserves and was able to weather the loss but it was difficult. We had to refund all vendor fees and sponsor fees, as well as not being able to hold our fundraiser raffle or sell our t-shirts. Our t-shirt vendor stepped up and hosted an online sale site and enabled us to sell enough t-shirts to breakeven on them. We were able to return the soda and water and some other supplies. Most of our providers did as much as they could and found ways to save us some money on their invoice. Still, the organization incurred a loss approaching \$100,000.

The 2021 Festival is still unscheduled. The continuing pandemic makes it impossible to plan and hold an event that typically draws more than 125,000 attendees. We keep hoping but it is not looking good. The organization is financially sound and if we cannot hold the event in 2021, we will look forward to 2022.
