The portfolio is invested in a manner that is intended to generate annual returns while assuming a moderate level of risk. The Board uses outside professionals to manage its investment portfolio. The endowment spending policy specifies an annual maximum of 3% based on the average of the prior twelve quarters. This annual maximum amount can be modified by vote of the full Board of Trustees.
