The collaboratives works include, convening with groups that focus specifically on the work of mitigating the effects of poverty, a bridging program for babies affected by neonatal abstinence syndrome, Family Futures Down-east for building family academic success and self sufficiency, Early Childhood Consultation and Outreach (ECCO) provides slow cost effective support for children in various environments and who need additional supports or skills, & Trainings for bridging programs provided trainings to approximately 700 individuals, non-training services were provided to 1,237 individuals. OTHER PROGRAM SERVICES 5: Group Homes - This program provides clients with developmental disabilities round the clock personal support in a home-like and safe residential environment. 12 clients received these services. OTHER PROGRAM SERVICES 6: Mental Health Services - Clients learn skills, increase their self-awareness and wellness, and are linked to services which enable them to live and work at their highest potential and meet their personal goals. Services provided include case management, daily living services, and outpatient counseling services. Approximately 70 clients received services. OTHER PROGRAM SERVICES 7: Program Management - Supports various local non-profit entities through administrative support services. OTHER PROGRAM SERVICES 8: Children's Services - Serves approximately 40 children with significant intellectual, emotional or behavioral disabilities. Providing home and community based treatment, rehabilitative and community support or child day treatment programs. Services include counseling, therapy, teaching, socialization, and applied behavioral analysis. All services were individually tailored to assist children to reach their full potential, to increase their inclusion in the community, & to sustain them in their family living situation of their choice.
