The candidates must outline in detail how they will meet the reporting guidelines and objectives and submit their quote of services for review. A committee is formed by MITC that reviews the applications and narrows down the candidate's for final vetting and approval to enter into a contract. The foreign based consulting company that is selected then signs a contract agreement for services with MITC and is required to submit monthly performance reports and invoices during the pre-determined execution period for the grant funding. On a monthly basis the reports are reviewed by the Director in charge of the overseas activity and once the report is accepted they would then authorize financing to make payment by wiring funds to the foreign based organization. All supporting documentation is kept by the finance department as backup. On a quarterly basis MITC submits to the grant issuing organization a request for reimbursement based on the fully executed grants that were paid in that quarter.

In the specific case of SBA STEP Grants, the application is then sent to the MITC Grant Committee, which currently consists of three representatives assigned by the Trade Center President, their duty is to verify that the Grant application approved by MITC meets the SBA STEP Guidelines as determined by the Grant Awarded, currently the committee consists of the MITC Board Chair, MEP President, and Director, U.S. Commercial Services located in Portland, ME. Once an application is approved, the business is then authorized to attend the Trade Mission/Trade Show or Training with the understanding that upon return they will be required to complete a post event survey and submit receipts as supporting backup for the amount of reimbursement they are requesting. The grant receipts are then reviewed by Finance and kept for supporting backup. On a quarterly basis MITC submits to the Grant issuing organization (SBA, etc) a request for reimbursement based on the fully executed Grants that were used in that quarter. Once funding is received by the grant issuing organization the authorization is then given by the President to reimburse the company for their expenses.
