AMENDMENT: KEISER S ORWELL EASEMENT: THIS CORRECTIVE AMENDMENT FURTHER CLARIFIES THE BOUNDARIES OF THE GRANT OF DEVELOPMENT RIGHTS AND CONSERVATION RESTRICTIONS.
