

WE CURRENTLY HAVE A MAJOR CAPITAL CAMPAIGN AND DESIGN/CONSTRUCTION WORK UNDERWAY TO RENOVATE OUR THEATER. DUE TO THE EFFECTS OF COVID-19, WE CANCELLED ALL PERFORMANCES BEGINNING EARLY IN CALENDAR 2020. OUR FINANCIAL RESULTS THEREFORE REFLECT THE LOSS OF SHOWS AND SUMMER PROGRAMMING, THE INFLOWS FROM CONTRIBUTIONS FROM THE CAPITAL CAMPAIGN, THE OUTFLOWS OF EARLY RENOVATION WORK, AND SIGNIFICANT GRANT AWARDS RELATED TO THE RENOVATION AND PANDEMIC RESPONSE.
