Together with our Donors we make it possible for more Vermonters to aim higher, go further, and build something better for themselves, for their families, for their community, and for our shared world. We partner closely with our donors to create scholarship funds that reflect their personal and philanthropic values as well as their financial goals, so they can help open the doors to higher education for others. We administer all scholarships through VSAC, with ongoing support that makes managing a scholarship easy. VSAC currently awards about \$6.1 million in scholarships to over 3,450 Vermonters.
