WE OFFER FULL-DAY EARLY CHILDHOOD EDUCATION AS WELL AS AFTER SCHOOL AND FULL-DAY SUMMERTIME PROGRAMMING THAT FOCUSES ON ACADEMIC ACHIEVEMENT, EMOTIONAL DEVELOPMENT, AND ARTS ENRICHMENT. WHILE CAMP HALE WAS CLOSED IN FY20 DUE TO COVID-19, USES OFFERED VIRTUAL PROGRAMMING TO CAMP HALE PARTICIPANTS AND THEIR FAMILIES.
