THE ENVIRONMENTAL LEAGUE OF MASSACHUSETTS (ELM) IS COMMITTED TO COMBATING CLIMATE CHANGE AND PROTECTING THE COMMONWEALTH'S LAND, WATER, AND PUBLIC HEALTH. BY CREATING DIVERSE ALLIANCES AND BUILDING THE POWER OF THE ENVIRONMENTAL COMMUNITY, ELM USES ITS COLLECTIVE INFLUENCE TO ENSURE MASSACHUSETTS IS A LEADER IN ENVIRONMENTAL AND ECONOMIC SUSTAINABILITY. AS A MASSACHUSETTS-BASED ORGANIZATION THAT ENGAGES IN ADVOCACY ACROSS A FULL SPECTRUM OF CLIMATE, ENVIRONMENTAL, AND CLEAN ENERGY ISSUES, ELM PLAYS A CRUCIAL ROLE IN COORDINATING AND ELEVATING THE ENVIRONMENTAL COMMUNITY TO PUSH FOR POLICY CHANGE AND REGULATORY OVERSIGHT.
