F.Y. Eye achieves its mission by developing and disseminating PSAs (Public Service Announcements) that generate attention and action on issues of public concern. Their signature program is a community media cooperative (the digital PSA Network), an ecosystem of over 100 indoor and outdoor digital billboards strategically placed in high-visibility public and nonprofit spaces. This growing network of screens was created specifically and exclusively for social impact messaging, and they offer nonprofits ad space on this media channel for free. Current media venue include billboards, telephone kiosks, bus shelters and transit ads, internet, movie theatre pre-film advertising, events, radio ads and plasma video displays in libraries, colleges and nonprofit locations
