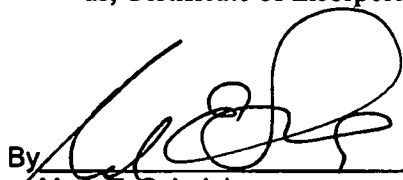
WHEREAS, the Board of Trustees of the Corporation wishes to change its formal corporate name to reflect its status as a university;

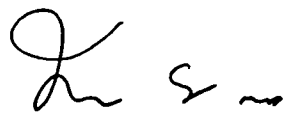
