THESE PAYMENTS ARE SUBJECT TO AUDIT AND COMPLIANCE W ITH FEDERAL REGULATIONS. THE COLLEGE BELIEVES IT HAS MET THE CONDITIONS TO RETAIN THESE FU NDS, AND NO AMOUNTS ARE RESERVED FOR REPAYMENT AT JUNE 30, 2020 IN THE ACCOMPANYING STATEM ENTS OF FINANCIAL POSITION. THE BALANCE OF THE CARES FUNDING RECEIVED RELATED TO THIS GRAN T, \$1,630,443, IS INCLUDED IN DEFERRED REVENUE ON THE ACCOMPANYING STATEMENTS OF FINANCIAL POSITION. THE COLLEGE MET THE REMAINING CONDITIONS OF THIS GRANT AND, THEREFORE, RECOGNIZ ED THE REMAINING BALANCE AS REVENUE IN FISCAL 2021.
