This marks the sixth production of Sheldon's plays, which include Shiverman, nominated as Best Play of 2012 by London's Off-West End Awards. Directed by Tony Award-nominee Michele Shay (August Wilson's Seven Guitars and Raisin in the Sun on Broadway, The Old Settler at The Billie, 2018 AUDELCO-winning Best Revival of the Year) Reparations stars Lisa Arrindell (Cat on a Hot Tin Roof on Broadway, A Lesson Before Dying, Madea's Family Reunion), Kamal Bolden (The Resident, Chicago Fire, Rosewood), Alexandra Neil (Madoff, and Rock 'n' Roll and Match on Broadway), and Gys de Villiers (Mandela Long Walk to Freedom, Vehicle 19, It Gets Better). Before it Hits Home - Cheryl West's Before It Hits Home, winner of the Susan Smith Blackburn Prize, tells the brutal and at times tender story of the impact of the AIDS crisis on an African American in the midwest and their community. Aptly timed, a 2019 report by the Center for Disease Control shows that after five years of declining rates, HIV infections are on the rise in Brooklyn, the only borough that saw an increase. Black individuals are more than three times as likely as their white counterparts to be infected with the virus and once infected, they are twice as likely to die from the disease. Originally scheduled for Spring 2020, Before It Hits Home was in its third week of rehearsals and the set had been built when the COVID-19 shutdown occurred. We will instead present 34 performances in October-November 2021.

The "Black Lives Matter" letters were directed by Dawud West with creative direction from renowned artist Cey Adams, who famously completed the American flag mural for the opening of the National Museum of African American History and Culture. The mural includes 20 bars, with the names of the victims of police brutality and racially-motivated killings in this country from Emmett Till to George Floyd, with sadly more names added since. Mayor de Blasio closed the street to pedestrians-only for the duration of the summer so residents and visitors could experience this work spanning 565 Feet and 28 feet tall.
