ARTS CENTER: IN FISCAL YEAR 2020, ABRONS ARTS CENTER ATTRACTED 21,064 AUDIENCE MEMBERS FROM ACROSS THE CITY, AS WELL AS NATIONAL AND INTERNATIONAL ART ENTHUSIASTS. A THRIVING ARTIST-IN-RESIDENCE PROGRAM AND ON-SITE ARTS EDUCATION PROGRAMMING PROVIDED MULTI-DISCIPLINARY CLASSES IN MUSIC, DANCE, THEATER, AND THE VISUAL ARTS TO 877 CHILDREN AND ADULTS OF AGES AND SKILL LEVELS.
