A PARTNERSHIP WITH ROUND SQUARE, AN INTERNATIONAL CONSORTIUM OF SCHOOLS, LED TO A ZOOM EVENT HOSTED BY RIVERDALE AND ATTENDED BY STUDENTS AROUND THE WORLD. THE UPPER SCHOOL'S GLOBAL STUDIES PROGRAM OFFERED VIRTUAL EXCHANGES WITH England AND SPAIN IN LIEU OF TRIPS TO THOSE COUNTRIES.
