The AOP 2019-20 season saw its most diverse group of fellows and students enter its 10th cycle of the Composers & the Voice fellowship training program and another semester of the NYU Tisch Opera Lab. The season kicked off with an encore presentation of The Stonewall Operas, four one-act operas from the NYU Opera Lab that premiered in June 2019 on the 50th anniversary of the LGBTQ uprising. AOPs renowned opera development program First Chance gave opportunities to a wide range of artists to workshop new works of lyric theater including The Night Falls, Ga Sho, The Christmas Spider, Precipice, and Eat the Document many with intimate performances allowing the public to experience the creative process and meet the creators. AOPs commitment to the creation of contemporary opera was also recognized during the OPERA America New Works Showcase in January 2020 in which AOP hosted Spoleto Festival USA and Music-Theatre Group at the Brooklyn Academy of Music's Lepercq Space/BAMCaf, featuring three new works fusing opera and folk: Omar (Rhiannon Giddens and Michael Abels); Marymere (Matthew Schickele); and Hatuey (Frank London and Elise Theron). The capacity audience included many representatives from opera companies around North America. Opera companies around North America continue to recognize AOPs contribution to American opera with new productions of As One at Opera Memphis, Bay Chamber Concerts, Boston University, and Pensacola Opera, to name a few. The chamber opera As One (the first opera about a transgender person), has become the most-produced opera written in the 21st century, with over two dozen separate productions since the AOP premiere in 2014. AOPs touring production of As One was produced at Opera Columbus in November 2019. Despite the obstacles faced in 2020, AOP continued its mission with remote workshops and online offerings, including live concerts, original videos, and interactive events. In its artistic community, AOPs focus was on maintaining the integrity of the artists process, while navigating the challenges of remote and distanced creation. By finding new ways to adapt, AOPs online platform activated its alumni community, provided personal and inspiring conversations with artists, and introduced shows addressing social change, such as Keep On Going, a video released in partnership with neighbors BRIC Arts Media that brought together the original cast of Nkeiru Okoyes Harriet Tubman to sing the operas anthem as a message of hope dedicated to the doctors, nurses, workers, and patients at The Brooklyn Hospital Center in Fort Greene, and to all essential workers. After being forced to cancel the majority of its Spring offerings, AOP quickly adapted its season to the challenges of the COVID-19 epidemic by moving its rehearsals and music training programs to Zoom and creating artist-safe environments and partnerships with film and new media companies to professionally record events for online distribution. In response to the abrupt halt of live performance, AOP introduced new and varied digital offerings that continued to connect art with audience despite our physical distance. A trove of archived AOP performances reappeared, including the world premieres of As One, Harriet Tubman, Three Way and The Echo Drift. AOP also programmed online concerts of support for unemployed artists, essential workers and those affected by the racial unrest sparked by the murder of George Floyd in Minneapolis in May. During this pandemic programming, AOPs online community expanded exponentially, with website visits increasing over 200% and page views over 250%, largely due to its social media presence and engaging digital content during a time of isolation.
