

OTHER PROGRAMS: NATIONAL HISTORY TEACHER OF THE YEAR AWARD PROGRAM, NATIONAL BOOK PRIZES, CONFERENCES OUTREACH, AND SCHOLARLY FELLOWSHIP PROGRAM. IN SPRING 2020, IN RESPONSE TO THE COVID-19 HEALTH CRISIS, GILDER LEHRMAN LAUNCHED A NUMBER OF NEW DIGITAL PROGRAMS FOR TEACHERS, STUDENTS, AND THE GENERAL PUBLIC. IN APRIL 2020, DUE TO THE CLOSING OF THE COLLECTION TO VISITORS, THE INSTITUTE CREATED THE ONLINE PROGRAM INSIDE THE VAULT: HIGHLIGHTS FROM THE GILDER LEHRMAN COLLECTION, WHICH HAS NOW SERVED MORE THAN 21,000 TEACHERS, STUDENTS, SCHOLARS, AND OTHER LOVERS OF HISTORY. GILDER LEHRMAN HISTORY SCHOOL, AN ONLINE PROGRAM, ANSWERED THE NEED FOR HISTORY EDUCATION THAT STARTED WHEN SCHOOLS WERE FIRST CLOSED IN MARCH OF 2020. THE GILDER LEHRMAN HISTORY SCHOOL BEGAN WITH POP-UP COURSES STARTING ON APRIL 27. ONE OF THE INSTITUTE'S NEW, EXCITING, AND ENGAGING PROGRAMS FOR THE GENERAL PUBLIC IS BOOK BREAKS. EVERY SUNDAY, BEGINNING ON MAY 10 WITH ERIC FONER, RENOWNED HISTORIANS AND AUTHORS WERE INTERVIEWED ABOUT THEIR NEW OR OTHERWISE CORNERSTONE PUBLICATIONS. WITH THE LAUNCH OF THE HAMILTON EDUCATION PROGRAM ONLINE ALREADY PLANNED FOR FALL 2020, THE INSTITUTE QUICKLY CREATED HAMILTON AT HOME IN SPRING 2020, OFFERING THE RESOURCES OF EDUHAM ONLINE TO FAMILIES AT HOME WITH EAGER STUDENTS OF HAMILTON AND HISTORY.
