DASSdance School offers year round inclusive contemporary dance education opportunities for all ages. We continue to grow our outreach program with the Associated Recreation Council, reaching local public schools with quality dance programming in a variety of styles. This season DASSdance introduced the world premiere of "Seattle City Nutcracker", a contemporary take on a time-honored tradition that showcased a mechanical doll lit with LEDs flying above the stage, black-lit AI robots in the battle scene, and an authentic journey around the world in the land of the sweets which included "African Flowers", danced by local Hip Hop group Kutt'N'Up. "Spanish" was danced by a former student of our DASSdance Director and current member of the Dance Theatre of Harlem. Families in need received half priced or free tickets.
