The Carleton Laboratory used funds received from the Carleton Trust for the 2019-2020 tax year to pay for staffing and research support and to cover ongoing improvement and modernization of the Laboratory facilities. In the past tax year, the funds distributed from the Christine Carleton Charitable Trust have been applied to core facility maintenance and upgrades including: floor refinishing in areas of the lab dedicated to the undergraduate student project building, area and upper west crane bay; student lounge refresh with a new mediascape lounge landscape that promotes collaboration in a social and informal setting to support the exchange of ideas; electrical system upgrades and replacement of original electrical

and replacement and upgrade of various large pieces of the lab's core equipment portfolio including Sample Loading Cranes and the MTS Landmark 22K Universal Testing Machine. The Carleton Trust supports the laboratory staff which during the COVID-19 pandemic worked with NY hospitals and health systems to design and manufacture desperately needed oxygen hoses and wye-splitters for ventilators used to treat COVID-19 patients.

The Laboratory staff also participated in the rapid design and production of plastic face shield personal protective equipment used by health care workers on the front lines of the fight against COVID-19.
