We coordinated and provided 28 forensic medical exams for child sexual assault victims. 21 Child Protect cases resulted in criminal charges against suspected child abuse perpetrators. We had 7 criminal convictions on child abuse related crimes in 2020 We referred 65 individuals for mental health counseling services and we provided trauma-focused therapy services to 161 trauma survivors in 2020. We provided advocacy and support services to all 182 new children served in 2020.
