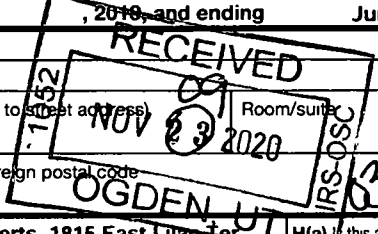

FIRST LEGO League has 2 subprograms - FIRST LEGO League Challenge and FIRST LEGO League Explore  
FIRST LEGO League Challenge - Over 525 teams participated in the FIRST LEGO League Challenge program in Illinois. After over 40 qualifying tournaments, there were three state championship events. Approximately 3700 students were involved in the FIRST LEGO League Challenge Program.

FIRST LEGO League Explore - Approximately 100 teams participated in the FIRST LEGO League Explore program with approximately 500 students participating. A series of FIRST LEGO League Junior showcases were held in Illinois, however half our of our events for this program were canceled as a result of COVID19.

FIRST Tech Challenge - Over 200 teams participated in Illinois during the past year. The season included leagues, meets and qualifying tournaments and an Illinois State wide Championship. Approximately 1700 students were involved in the program.

FIRST Robotics Competition. The FIRST Robotics Competition activity in Illinois is run by FIRST (501c3 in New Hampshire). Inscite Illinois (DBA FIRST Illinois Robotics) assists FIRST in this program. The majority of the revenue within Inscite Illinois related to the FIRST Robotics Competition was local fund raising and expense payments to FIRST to cover a portion of running the Midwest Regional FIRST Robotics competition in Chicago. Approximately 1600 students were involved on teams in Illinois.
